THE VIRGINIA D.H. FURMAN OUTSTANDING MEMBER OF THE YEAR AWARD

The Virginia D.H. Furman Outstanding Member of the Year Award, named for Financial Women International's first president, is presented each year to the FWI member who demonstrates exceptional achievements in the association. All members, excluding current members of the FWI International Board of Directors, are eligible to receive the award. All group and district leaders, members of committees, and individual members are encouraged to participate. Established in 1996, the award is presented at FWI's annual conference.

The following criteria are used to select the Virginia D.H. Furman Outstanding Member of the Year. In your nomination, you should describe how the member accomplished the following.

- 1. List specific examples of how the nominee supports FWI's mission of helping women achieve career success. (25%)**
- 2. How has the nominee excelled in developing and/or mentoring other FWI members or an FWI group and/or district during the current fiscal year? (25%)**
- 3. What specific FWI accomplishments can be attributed to the nominee for the current fiscal year (i.e., reorganizing a struggling group, recruiting an extraordinary number of members, achieving excellence in fundraising, or impacting diversity of FWI membership)? Please be specific and use percentages and amounts wherever possible. (50%)**

Each nomination will require two nominators. To nominate a member for this prestigious award, complete the attached form listing the accomplishments of the nominee in relation to the above criteria.

Responses must be limited to the front and back of an 8 1/2-by-11 inch sheet of paper.
